INSTRUCTION FOR ONLINE BID SUBMISSION

The bidders are required to submit soft copies of their bids electronically on the Central Public Procurement (CPP) Portal ie <http://eprocure.gov.in/eprocure/app> , using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

REGISTRATION

- (i) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL:<https://eprocure.gov.in/eprocure/app>) by clicking on the link "Online Bidder Enrolment" option available on the home page. **Enrolment on the CPP Portal is free of charge.**
- (ii) During enrolment/ registration, the bidders should provide the correct/ true information including valid email-id & mobile no. All the correspondence shall be made directly with the contractors/ bidders through email-id provided.
- (iii) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- (iv) For e-tendering possession of valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) is mandatory which can be obtained from SIFY /nCode/eMudra or any Certifying Authority recognized by CCA India on eToken/ SmartCard.
- (v) Upon enrolment on CPP Portal for e-tendering, the bidders shall register their valid Digital Signature Certificate with their profile.
- (vi) Only one valid DSC should be registered by a bidder. Bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse and should ensure safety of the same.
- (vii) Bidders can then log into the site through the secured login by entering their userID/ password and the password of the DSC/ eToken.

SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords, etc., to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

PREPARATION OF BIDS:

- (i) For preparation of bid Bidders shall search the tender from published tender list available on site and download the complete tender document and should take into account corrigendum if any published before submitting their bids.
After selecting the tender document same shall be moved to the 'My favourite' folder of bidders account from where bidder can view all the details of the tender document.

- (ii) Bidder shall go through the tender document carefully to understand the documents required to be submitted as part of the bid. Bidders shall note the number of covers in which the bid documents have to be submitted, the number of documents – including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- (iii) Any pre-bid clarifications if required, then same may be obtained online through the tender site, or through the contact details given in the tender document.
- (iv) Bidders should get ready in advance the bid documents in the required format (PDF/xls/rar/dwf/jpg formats) to be submitted as indicated in the tender document/schedule. **Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.**
- (v) Bidders can update well in advance, the documents such as experience certificates, annual report, PAN, EPF & other details etc., under “My Space/ Other Important Document” option, which can be submitted as per tender requirements. This will facilitate the bid submission process faster by reducing upload time of bids.

SUBMISSION OF BIDS:

- (i) Bidder should log into the site well in advance for bid submission so that he/ she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay.
- (ii) Bidder should prepare the EMD as per the instructions specified in the NIT/ tender document. The details of the DD/BC/BG/ others physically sent, should tally with the details available in the scanned copy and the data entered during bid submission time. Otherwise the uploaded bid will be rejected.
- (iii) While submitting the bids online, the bidder shall read the terms & conditions (of CPP portal) and accepts the same in order to proceed further to submit their bid.
- (iv) Bidders shall select the payment option as offline to pay the EMD and enter details of the DD/BC/BG/others.
- (v) Bidder shall digitally sign and upload the required bid documents one by one as indicated in the tender document.
- (vi) Bidders shall note that the very act of using DSC for downloading the tender document and uploading their offers is deemed to be a confirmation that they have read all sections and pages of the tender document without any exception and have understood the complete tender document and are clear about the requirements of the tender document.
- (vii) Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document. For the file size of less than 1 MB, the transaction uploading time will be very fast.
- (viii) **If price quotes are required in XLS format, utmost care shall be taken for uploading Schedule of quantities & Prices and any change/ modification of the price schedule shall render it unfit for bidding.**

Bidders shall download the Schedule of Quantities & Prices i.e. Schedule-A, in XLS format and save it without changing the name of the file. Bidder shall quote their rate in figures in the appropriate cells, thereafter save and upload the file in financial bid cover (Price bid) only.

If the template of Schedule of Quantities & Prices file is found to be modified/corrupted in the eventuality by the bidder, the bid will be rejected and further dealt as per provision of clause no 23.0 of ITB including forfeiture of EMD.

The bidders are cautioned that uploading of financial bid elsewhere i.e. other than in cover 2 will

result in rejection of the tender.

- (ix) Bidders shall submit their bids through online e-tendering system to the Tender Inviting Authority (TIA) well before the bid submission end date & time (as per Server System Clock). **The TIA will not be held responsible for any sort of delay or the difficulties faced during the submission of bids online by the bidders at the eleventh hour.**
- (x) After the bid submission (i.e. after Clicking “Freeze Bid Submission” in the portal), the bidders shall **take print out of system generated acknowledgement** number and keep it as a record of evidence for online submission of bid, which will also act as an entry pass to participate in the bid opening.
- (xi) Bidders should follow the server time being displayed on bidder’s dashboard at the top of the tender site, which shall be considered valid for all actions of requesting, bid submission, bid opening etc., in the e-tender system.
- (xii) All the documents being submitted by the bidders would be encrypted using PKI (Public Key Infrastructure) encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology.

INSTRUCTION FOR e-PROCUREMENT

1. PREPARATION AND SUBMISSION OF BIDS :

- a. The detailed tender documents may be downloaded from <http://eprocure.gov.in/eprocure/app> till the last date of submission of tender. The Tender may be submitted online through CPP Portal <http://eprocure.gov.in/eprocure/app>
- b. The bidder should submit the bid online in two parts viz. Technical Bid and Financial Bid. Technical Bid should be upload online in cover 1 and Financial Bid in “.Xls” should be upload online in cover-2

2. SUBMISSION OF THE BID : All interested eligible bidders are requested to submit their bids online on CPP Portal: <http://eprocure.gov.in/eprocure/app> as per the criteria given in this document:

- a. Technical Bid should be upload online in cover-1.
- b. Financial Bid should be upload online in cover-2

Both Technical and Financial Bid covers should be placed online on the CPP Portal (<http://eprocure.gov.in/eprocure/app>).

3. TECHNICAL BID: Signed and Scanned copies of the Technical bid documents as under must be submitted online on CPP Portal: <http://eprocure.gov.in/eprocure/app>.

- a) **List of Documents to be scanned and uploaded (Under Cover-1) within the period of bid submission:-**

4. Financial Bid

- a. The currency of all quoted rates shall be Indian Rupees/USD/Euro/GBP/CHF/JPY.
- b. In preparing the financial bids, bidders are expected to take into account the requirements and conditions laid down in this Tender document. The financial bids should be uploaded online as per the specified “.Xls” format i.e. Price Bid Excel sheet attached as ‘.Xls’ with the tender and based on the scope of work, service conditions and other terms of the Tender document. It should include all costs associated with the Terms of Reference/Scope of Work of the assignment.
- c. The Financial Proposal should be inclusive of all applicable taxes, duties, fees, levies, and other charges imposed under the applicable laws. The rates quoted in the Tender are inclusive of all applicable taxes, duties etc. **except service tax**. The service tax component shall be re-immersible by the department after receipt of paid challans

etc. if applicable.

5. Last Date for Submission of Tender:

- a. Online bids complete in all respects, must be submitted on or before the last date and time specified in the schedule of events.
- b. The IIT, Kanpur may, at its own discretion, alter/extend the last date for submission of tenders.

6. Bid Validity

- a. All the Bids must be valid for a period of 120 days from the last date of submission of the tender for execution of Contract. However, the quoted rates should be valid for the initial/ extended period of the Contract from the effective date of the Contract. No request will be considered for price revision during the original Contract period.
- b. A bid valid for a shorter period shall be declared as non-responsive.
- c. In exceptional circumstances, prior to expiry of the original time limit, the IIT may request the bidders to extend the period of validity for a specified additional period beyond the original validity of 120 days. The request and the bidders' responses shall be made in writing. The bidders, not agreeing for such extensions will be allowed to withdraw their bids without forfeiture of their Bid Security.

7. Modification / Substitution/ Withdrawal of bids:

- a. No Bid shall be modified, substituted or withdrawn by the Bidder after the Bid's due Date.
- b. Any alteration/ modification in the Bid or additional information supplied subsequent to the Bid's due Date, unless the same has been expressly sought for by the Authority, shall be disregarded.

8. Rejection of the Bid: The bid submitted shall become invalid and tender fee shall not be refunded if:-

- a. The bidder is found ineligible.
- b. The bidder does not upload all the documents as stipulated in the bid document.

Critical Terms & Conditions:

The Glove Box & Purification unit must be from the same manufacturer (Documentary evidence to be submitted by Manufacturer).

Minimum 40 installations of the instrument in India is a must with at least 20 installations in IIT's or an Institute of National importance like BARC, IISER, and Indian Oil. The documentary proof of installation in India needs to be submitted along with all contact details of users. Satisfactory performance report from at least last 3 years of the instrument needs to be submitted. Direct Presence of Service team along with contact details to be provided. Complete User List along with contact details to be provided.

Certifications Required from Manufacturer: ISO, CE, and Class 1 Tightness Certificate of the instrument.

Warranty: Three years warranty from the date of installation Plus one (01) year onsite extended warranty.

Technical Specification of Inert Gas Workstation

Modular Glove box having 2 glove ports (220 mm diameter, O ring sealed; one pair of butyl gloves should come with the system, not less than 0.6 mm thickness).

Front panel should be of Sapphire Coated Polycarbonate material.

Glove Box Workstation material must be of Stainless steel US304L (Low Carbon Steel 1.4306)

Internal dimensions 900-950mm x 1200-1250mm x 720-800mm [H x L x D] or better.

Controlled with Colour Touch panel.(Led retro lighting. Resolution 800 x 480 pixels) for operation of all Glove box functions.

Presence of LEDs lights during working either at front mounted or from ceiling of glove box controlled manually or automatic.

Leak rate should be less than 0.05 Vol %/automatic adjustable pressure regulation must be possible in the Glove Box without connecting to vacuum pump & need of foot pedal.

Glove box should have sufficient feed through including electrical & Blank• Tightness of glove box according to O₂-increase method. Class 1 glove box (according to International Standards ISO 10648-2 – Leak rate < 0.05 Vol%/h).Glove Box must have automatic pressure regulation system without having any dependence on the vacuum pump

- 2 Polymer glove ports, 220mm dia, O ring sealed,
- Front panel should be of Sapphire coated Polycarbonate material
- PLC Controlled with Colour Touch panel for operation of all Glove box functions - Including FLUSHING ,Graphical tend of box pressure, oxygen and moisture levels etc .
- Dust filter 0.3 micron, class H13, should be included
- Three Height Adjustable, Stainless Steel shelves to be included

Big Vacuum chamber

Big vacuum chamber of dimension 400 mm x 600 mm (DxL) stainless steel (US304L) with Sliding Tray. Leak rate < 10⁻⁵ mbar.l/s Fitted with analogue vacuum gauge.

Mini Vacuum chamber

Mini- Antechamber -150 (D) x 400 (L) mm, hinged doors, with sliding tray.

Gas Purification

Re-generable Filter for gas purification is required which maintains <1 ppm O₂ and H₂O level capacity.Purification Capacity should be between 30 Lfor O₂ and 1000 g for Moisture or better. Purification loads must not be less than 8Kg (4kg Copper catalyst & 4Kg Molecular sieves)

Regeneration

Automatic regeneration Sequence with nitrogen N₂ or Argon (5-10%)

Circulation Unit

Must be fitted with a Brushless blower of minimum 30m³/hour or better with noise less than 47dB

Oxygen Analyser

Ranges in ppm: (1-1000 ppm). Electronics: Integrated microprocessor control, selection of ranges, calibration. Dual display of values – Touch Screen and inline display on the analyser to verification of values in the touch screen. Data Readings: 2 wire loop powered connection via a 4-20 mA Analog output. Accuracy: +/- 1 ppm in full range. Repeatability: +/- 1% in full range Resolution: 0.1 ppm in full range

Moisture Analyser

Capacitive sensor type, Measuring Range: 0 – 1000 ppm, delivered with calibration certificate – Technology requiring no maintenance with phosphoric acid or similar.

Pressure Regulation

Automatic Pressure regulation without having any dependence on the VacuumPump. Pressure regulation required without foot pedal and the vacuum pump will have to be switched-off when vacuum chamber(s) will not be used (ENERGY SAVING mode). One Oil based Pressure safety release valve must be present with HEPA filter for automatic mechanical discharge of exceeded gases in the glove box, must have fast reactive pressure adjustment, increased comfort in handlings, excess gas discharge should be possible even in case of power break for safety regulations.Warning display in case of recirculation blower stop. Low noise level 49 dB (A) under purification and pressure regulation. The Glove Box & Purification unit must be from the same manufacturer (Documentary evidence to be submitted by Manufacturer)

Refrigerator

Deep Freezer of volume at least 25 litres with multiple trays inside with adjustable height.
Temperature Range up to – 40 °C.

Solvent Trap

Activated carbon Solvent trap (Minimum 6.5 Kg).

Vacuum Pump

- Rotary vane pump with Oil mist filter, Oil re-circulation
- Automatic gas ballast control, > 17m³/h, dual stage and must be from **Edwards**.

Valves/Piping:

Main purifier valves should be of electro-pneumatic. All piping and components must be in stainless steel (SS 304L - Low Carbon Steel)

Feedthroughs

Minimum 1 leak light electrical feed through Bi + T 220V and at least 4 blanked leak tight feedthroughs on the back side. BNC feedthrough 4pin and Banana feedthrough 4 pin needed for three electrodes electrochemical measurements inside.

1 Vacuum Feedthrough for filtration inside the glovebox.
