## Tender Notice No. 2/ 2013-14

On behalf of the Director, Indian Institute of Technology Kanpur, sealed tenders are invited from interested parties to run the canteen near JEE/GATE Office at IIT Kanpur. The canteen will be open from 9:00 am to 8:00 pm to meet the needs of students.

The duration of contract will be for **three years**, first three months being the probation period and on satisfactory completion of the probation period the contract will automatically be extended for rest of the period. However, in case of any defaults or negligence under such contract, the management committee may suggest to the Officer-in-Charge (Estate) to impose fine or penalty against the contractor or termination of the contract finally, as described in tender document at point 2 of APPENDEX-A.

Parties having adequate experience in running Canteen/Cafeteria/Fast Food Centre in Government department, public undertakings, renowned educational institutions or elsewhere may apply along-with sufficient proof of their experience and ability of running such canteen.

Tender document containing the details can be obtained from the Estate Office from 12.04.2013 to 18.04.2013 **during 0930 to 1230 hours & 2000 to 3000 hours** on **depositing Rs. 210/-** (Rupees Two Hundred Ten Only) by cash. The **tenders** shall be **received on 22.04.2013 up-to 1200 hrs** in the **Estate Office** and will be opened on the same day at **1600 hours** in Room No. 212 Faculty Building. The parties will be required to meet to Committee for interview and finalization of the offer on same day.

An earnest money amounting to **Rs. 25,000/-** for the canteen will be deposited along-with the tender in the form of **FDR** of a scheduled bank drawn in favour of **"The Registrar, IIT Kanpur"**. On award of contract, the contractor will be required to pay regularly by **7<sup>th</sup>** of each month a monthly license fee of **Rs. 960/-** per month (including water charges) to the Estate Office for Academic canteen, and the payment of electric tariff on the basis of actual consumption through the meter installed in canteen. The earnest money of the successful tenderer shall remain with the Institute against security deposit. Tenders received without requisite earnest money will be summarily rejected. However, the Institute reserves the right to accept/reject any tender on the basis of merits/demerits without assigning any reason.
