- 3.Experience Criteria: The Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for 3 years before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the year. - 20.NET WORTH: Net Worth of the OEM should be positive as per the last audited financial statement.
- 21.Buyer Added text based ATC clauses Training and Installation: The bidder should provide appropriate and detailed training on the use of auto pilot and help in installation of the equipment on UAV.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization.
