- 1. - 1.3 Delivery period: The Delivery Period/Time shall be essence of the Contract and delivery must be completed not later than such date(s). Any modification thereto shall be mutually agreed and in corporated in the Contract as per the provisions of the GTC.
- 1.4 Performance Security: If the Seller fails or neglects to observe or perform any of his obligations under the contract it shall be lawful for the Buyer to forfeit either in whole or in part, the Performance Security furnished by the Seller.
- 1.5 Taxes and Duties: Contract Prices are all inclusive i.e. including all taxes, duties, local levies / t

ransportation / loading-unloading charges etc. Break up of GST shall be indicated by the Seller whi le raising invoice / bill on GeM. While submitting the bill / invoice Seller shall undertake that the Go ods and Services Tax (GST) charged on this bill is not more than what is payable under the provisi on on the relevant Act or the Rules made there under and that the Goods on which GST has been c harged have not been exempted under the GST Act or the Rules made there under and the charge s on account of GST on these goods are correct under the provision of that Act or the rules made there under.

- 1.6 Octroi Duty and / or other local taxes: Contract Prices are all inclusive hence no reimbursemen t over and above the contract price(s) shall be allowed to seller towards payment of local taxes (su ch as levy of town duty, Octroi Duty, Terminal Tax and other levies of local bodies etc).
- 1.7 Limitation of Liability: The provisions of limitation of liability between Buyer and Seller as give n in the GTC shall be applicable here.
- 1.8 Resolution of disputes: The provisions of DISPUTE RESOLUTION BETWEEN BUYER AND SELLER as given in the GTC shall be applicable here.

- 1.10 Financial Certificate:

- 1.10.3 I have been fully authorized by the department to sign the supply order or incur the liability of the Goods being ordered.

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
